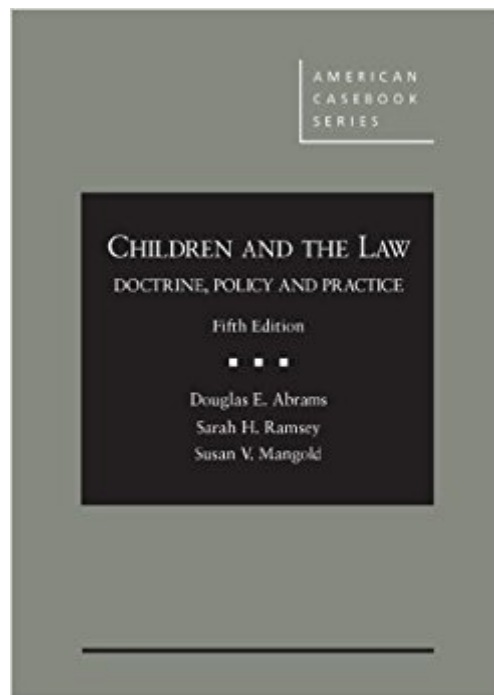

This casebook was required for my "Children & The Law" course. It is poorly organized. To illustrate, early in the casebook the authors discuss many of the legal disabilities placed on children born to unwed parents. However, it picks up that same discussion later in the text when it discusses adoption. This type of "organization" is present throughout the entire text and makes outlining

unnecessarily difficult. The Nutshell is a mere reiteration of this casebook without all the incredibly boring and theoretical law review articles that take up about 30% of the casebook.

As I'm sure many a person did, I got this for a course in law school, but I was miffed that I had to splurge this much for 1 textbook, but it's a good book, effectively covering material on case law, and going into the analysis for each supreme-court justice's reactions to the particular case at hand. Personally, I'd shop around to see if your law bookstore has one cheaper. But if you're going into child advocacy, a book such as this is essential. One little issue is there are a couple of typos, nothing too major, just missing a 't' in there, and the like, usually it's the first letter of the words. Found 3 so far in the first 80 pages, so not too bad, but kind of eyebrow-raising in any event.
