

John L. Mikesell (Ph.D. in economics, University of Illinois) is Chancellor's professor of public and environmental affairs at Indiana University-Bloomington. His work on government finance and taxation has appeared in such journals as *National Tax Journal*, *Public Budgeting and Finance* (for which he serves as editor-in-chief), *Public Finance Quarterly*, *Southern Economic Journal*, *Public Administration Review*, *Public Choice*, *International Journal of Public Administration*, and *Journal of Public Budgeting, Accounting, and Financial Management*. He is co-author of *SALES TAXATION, STATE AND LOCAL STRUCTURE AND ADMINISTRATION* (Urban Institute Press). His distinguished career includes serving as chief fiscal economist on the USAID Barents Group/KPMG Peat Marwick fiscal reform project with the Government of Ukraine (1995) and as director for assistance in intergovernmental fiscal relations with the USAID Georgia State University Consortium Russian fiscal reform project (1998-99). He directed U. S. Department of State supported public administration partnerships involving institutions in the U.S. and Russia, and has worked on fiscal

studies for several states, including New York, Minnesota, Indiana, and Hawaii; as consultant on World Bank missions to several countries; and as a Senior Research Fellow, Peking University-Lincoln Institute Center for Urban Development and Land Policy in Beijing. Dr. Mikesell received the 2002 Wildavsky Award for Lifetime Scholarly Achievement in Public Budgeting and Finance from the Association for Budgeting and Financial Management.

This book is written so poorly I can barely get through it. Mikesell goes on and on with run-on sentences, excessive details that get in the way of the concepts, and very poor organization of the concepts. He shifts styles, meanders off topic, and fails to get to the point. He also uses very few graphs or illustrations. Instead, he includes large tables of numerical data (rather than a chart, like a pie, line, or bar graph, that would bring out the important message). Even though it's in the 7th edition, it reads like a rough first draft. It needs major revision. In order to get through it, I skim for the ideas and skip a lot of the text. When I try to "read" it (i.e. every word), I get so bogged down, I can't move forward and I don't retain much. Mikesell obscures the main concepts in a haze of excess words, unhelpful information, and pervasive use of the passive voice. Unfortunately, I have to use this book for my graduate Public Financial Management course. If you have the choice, find something better.

In my years in undergrad, law school, and grad school, I have never encountered such a disorganized mess of a book. The fact that I actually had to pay hundreds of dollars for this atrocity makes me sick. The chapters are not outlined in a manner that enables the reader to understand how the topics and positions related. The information conveyed is boring, and the author expends far too many words attempting to explain his points. HATE THIS BOOK, and the price I paid for it. If this class wasn't a requirement, I would've dropped it solely on the basis of this course text.
